***Group Sponsorship**

Sponsorship can be carried out within a group of people, such as a community group. If you are part of such a group that would be interested in group sponsorship, please contact us.

NB: the below 'Nominations' and 'Sponsor-Resident Interaction' sections do not apply to sponsorship carried out outside of a group, such as signing up via the YMCA website.

Nominations

Any group sponsoring a room can nominate an individual for that room if vacant. If no nomination from the sponsoring group exists, Bournemouth YMCA will use the room to accommodate any suitable individual referred by another route.

If an individual nominated by a sponsoring group is accepted for accommodation by Bournemouth YMCA, the group may not choose to withdraw sponsorship of that individual in favour of another. This stipulation does not waive the 'Termination of Sponsorship' clause, below.

Sponsor-Resident Interaction

The paramount consideration is the protection of the resident's privacy, confidentiality and overall wellbeing. With this in mind, and depending of the resident's circumstances, it may be inappropriate for the sponsoring group to have any contact with the resident.

If the resident is from within the sponsoring group, or was known to that group prior to taking up residence with Bournemouth YMCA, sponsor-resident interaction can continue in the existing manner.

Otherwise, if contact is appropriate, a sponsoring group's interaction with a resident (including via a third party such as Bournemouth YMCA support staff) will be managed within the following parameters:

- Only with the resident's full knowledge and consent
- Primarily with designated person or persons from within the sponsoring group (it is acceptable for the resident to interact with others from within that group at the resident's own instigation)
- At the sponsoring group's, or individuals within that group's own risk

Safeguarding

Safeguarding of residents within Bournemouth YMCA's supported accommodation is in accordance with the Association's safeguarding and protection from abuse policies and procedures.

Within the context of a group's sponsorship of a room, the following principals are of note:

- The sponsoring group will place no requirement, expectation or obligation upon the resident, the resident's keyworker, or the nature and direction of the support provided by Bournemouth YMCA
- Information about the resident will only be exchanged between Bournemouth YMCA and the sponsoring group in cases where there is deemed to be a risk of harm to the resident or to others
- If Bournemouth YMCA or the sponsoring group become aware of such a risk, each party will be responsible for actioning their own appropriate policies and procedures.
