Frequently Asked Questions

What is a Legacy?

A legacy is leaving a gift for a charity in your will.

How do I leave a Legacy for the YMCA Bournemouth?

There are three main ways of leaving a gift.

- **1.** A cash gift (or pecuniary gift) this is a donation of a fixed amount.
- **2. A residuary gift** you can choose to leave us a percent age of what is left in your estate once you've provided for your loved ones.
- **3. A gift in kind** an item such as jewellery, furniture, property, etc.

Do I tell the YMCA Bournemouth about my gift?

This is entirely up to you. YMCA Bournemouth likes to know of planned gifts, so we can recognise your generosity. We can tell you about specific opportunities for giving. We can also assure you that your wishes can be fulfilled.

How does this affect inheritance tax?

Any gift you make to the YMCA Bournemouth is free from inheritance tax. So rather than 40% of your money going to the government, we receive 100% as a gift. If your estate goes over the inheritance tax threshold, a gift to charity can reduce its value so less tax is payable to the government and more goes to your loved ones and to the causes you care about.

Once he was strong enough, Mehdi stayed with family before returning to Bournemouth to relaunch his career. Today, Mehdi owns a number of venues in the local area. "YMCA Bournemouth can change your life, it changed mine."

What Legacy Funds have done?

Miss A recently supported YMCA Bournemouth through her will which enabled the trustees to commit to our Chatterbox project. The Chatterboxes is a youth action project run by young people with disabilities aged 11-25 years old from Bournemouth, Poole and other parts of Dorset.

How your gift could help

Here are just some of the ways a gift in your will could make an important difference:

- £50 Will provide an emergency food/toiletries parcel for a resident moving on
- £500 Will go a long way towards helping a homeless resident move back to independent living
- £5,000 would fund 100 free counselling sessions for people in need
- £50,000 would enable the YMCA to continue to help young people with disabilities to reach their full potential, via our Chatterbox project
- £100,000 would fund our Youth Services projects for one year

How to make a will

Making a will is one of those jobs that people don't get around to doing because they're worried it will be too complicated or costly. However, by making a will you can:

- Choose who is in charge of sorting out your estate.
- Appoint guardians for your children under 18.
- Choose who inherits what.

Going to a solicitor is the best way of making sure your will says what you want it to say.

Leaving money to a charity in your will can make financial sense too because charitable gifts are exempt from inheritance tax, so it can reduce the tax on your estate. Your financial adviser can help you with the latest in estate planning.
